

## Official “Monster Bash Pawty” Rules & Regulations

### ELIGIBILITY

1. The “Monster Bash Pawty” (the “Contest”) runs during regular store hours at participating **PET VALU, PAULMAC’S PETS, BOSLEY’S BY PET VALU, TISOL PET NUTRITION AND SUPPLY STORES** and **TOTAL PET** stores (the “Store” and/or “Stores”) in Canada between October 26th and October 31st, 2017 (the “Contest Period”). The Contest is open to residents of Canada (excluding Quebec) who have reached the age of majority in their province or territory of residence. THIS CONTEST IS VOID WHERE PROHIBITED BY LAW.

2. This Contest is not open to employees and agents of Pet Valu Canada Inc. (the “Sponsor”) and/or its affiliate(s), including **PET VALU, PAULMAC’S PETS, BOSLEY’S BY PET VALU, TISOL PET NUTRITION AND SUPPLY STORES** and **TOTAL PET** store employees and agents, or anyone domiciled with such person. This Contest is also not open to any franchisee of the **PET VALU** group (being **PET VALU, PAULMAC’S PETS** or **BOSLEY’S BY PET VALU** franchisees), or their employees or agents, or anyone domiciled with such person. Entrants may be asked to provide proof of identity and/or residency prior to being declared a winner.

### PRIZE

The approximate suggested retail price of each prize is \$63.51 (actual prices may vary).

Each prize shall be referred to hereafter as a “Prize” and, collectively, as the “Prizes”.

4. The Prize must be accepted as awarded, without substitution, is not redeemable for cash and is not transferable.

#### **HOW TO ENTER**

5. No purchase necessary. To obtain a ballot, visit any participating Store in Canada during the Contest Period (subject to availability) and **either** (a) have your pet dressed in a Halloween costume with you, or (b) purchase any Halloween costume from the Store during the Contest Period to receive a ballot. Complete the ballot by providing the requested information, including your full name and contact information. You must submit your ballot by depositing it in the in-store ballot box.

6. Ballots must be completed in full to be eligible for a draw. Sponsor is not responsible for entries that are late, lost, stolen, mutilated, illegible, incomplete or altered, all of which are void.

#### **CONTEST DRAW AND ODDS OF WINNING**

7. On or about November 1, 2017 a random draw consisting of all entries deposited at a particular store, will be conducted at each of the participating Stores across Canada to select an entrant to be eligible for the prize available at that store. Following the draw, reasonable attempts will be made to contact the selected entrant by telephone or email. If the selected entrant cannot be contacted, if there is a return of any notification as undeliverable, or if the selected entrant fails to respond within three (3) business days of initial attempt at contact, then that selected entrant will be disqualified and an alternate eligible entrant may be selected by random draw from among the remaining eligible entries.

8. Before being declared a winner of a Prize, each selected entrant must first correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill testing question, and may also be required to complete, sign and return a declaration and release form, including a publicity release, within the time specified on such form. In the event that a selected entrant does not correctly answer the mathematical skill testing question in the manner prescribed, fails to return the completed declaration and release form within the time specified, or otherwise is not in compliance with these Rules & Regulations, then that selected entrant will be disqualified (and will forfeit the Prize) and an alternate eligible entrant may be selected from remaining eligible entries in accordance with these Rules & Regulations.

9. Odds of winning in a particular Store's draw depend on the total number of eligible ballots received at that Store during the Contest Period.

10. The Prize can be picked up at the Store from which the winner was selected.

#### **GENERAL**

11. The Sponsor reserves the right to modify, amend, withdraw or terminate this Contest and/or modify or amend these Rules & Regulations at any time without prior notice, subject to applicable law.

12. All Contest entry ballots become the property of the Sponsor and none will be returned.

13. By entering the Contest, entrants agree to (i) abide by these Rules & Regulations and the decisions of the Sponsor which shall be final and binding, (ii) release and hold harmless each of the Sponsor, its affiliates, and franchisees of the **PET VALU** group (being **PET VALU**, **PAULMAC'S PETS** or **BOSLEY'S BY PET VALU**), and each of their respective officers, directors, shareholders, employees, representatives,

agents, successors and assigns, from and against any and all claims or causes of action, including but not limited to, personal injury, death, damage to or loss of property, or other liability that may arise from the entrant's participation in this Contest or the awarding, acceptance, use, or misuse of a Prize, and (iii) waive all rights to claim punitive, incidental and consequential damages, legal fees or damages.

14. By accepting a prize, each winner agrees that the Sponsor may use and publish, and may share with the applicable Store to use and publish, the winner's name, statements and photos of the winner and/or the winner's pet on the corporate or local social media platforms or the corporate websites.
